Part II addresses the jurisprudence of substantive criminal law, which is still mired in the dualism and formalism of a much earlier era that largely neglects the actor's biography. Part III speaks to anticipated objections and proposals for change. The work ends by drawing on the work of the philosopher John Rawls's well known "Original Position," a thought experiment on the treatment of damaged children.

This book should be of interest to anyone who teaches criminal law and procedure or is involved in the administration of criminal justice, including those individuals who provide social services to the incarcerated. It could be an assigned text in a law and psychiatry course or a criminal law or jurisprudence seminar.
